

# Terms and Conditions of Entry

## INTRODUCTION

The promoter is the National Grower Register Pty Ltd ABN 89 095 857 266 (NGR), 16 Mann Street, Toowoomba, QLD 4350, (ph.) 1800 556 630. By providing NGR with valid details of either the Farm Gate GPS coordinates or the Farm Gate location address, which will be used to populate the geo-coordinates for an NGR Growers' Registration Number (GRN), you are deemed to have accepted these Terms and Conditions.

## HOW TO ENTER

Entry is free and open to all NGR Users with at least one Registered GRN who;

1. Provide valid details of either the:
  - Farm Gate GPS coordinates; or
  - Farm Gate location address to be used to populate the geo-coordinates,
2. Are Australian resident and,
3. Aged eighteen (18) and over.

## NUMBER OF ENTRIES

Entries are made by NGR Users, with a Registered GRN, by providing NGR with either the Farm Gate GPS coordinates, or the address for the Farm Gate location (will be used to populate the geo-coordinates) for a Registered GRN, which will provide the Primary User of the Primary Payee, with one (1) ticket into the draw. Incomplete entries will be deemed invalid.

## START DATE AND END DATE

The Competition will start at 9am (AEST) on Monday 5<sup>th</sup> November, 2018 and will close at 5pm (AEST) on Thursday 31<sup>st</sup> January, 2019.

## DRAWING DATE AND SELECTION OF WINNERS
